### Substance Abuse Prevention

This fact sheet provides county level data on substance use and related factors to help guide decisions about prevention efforts. These data can be used to justify need for prevention funding, monitor substance-related trends, and plan programs and initiatives by establishing community level prevention priorities.

According to 2016 estimates from the U.S. Census Bureau, McLeod County has 35,842 residents; 23% are under the age of 18.

### Adult Substance Use

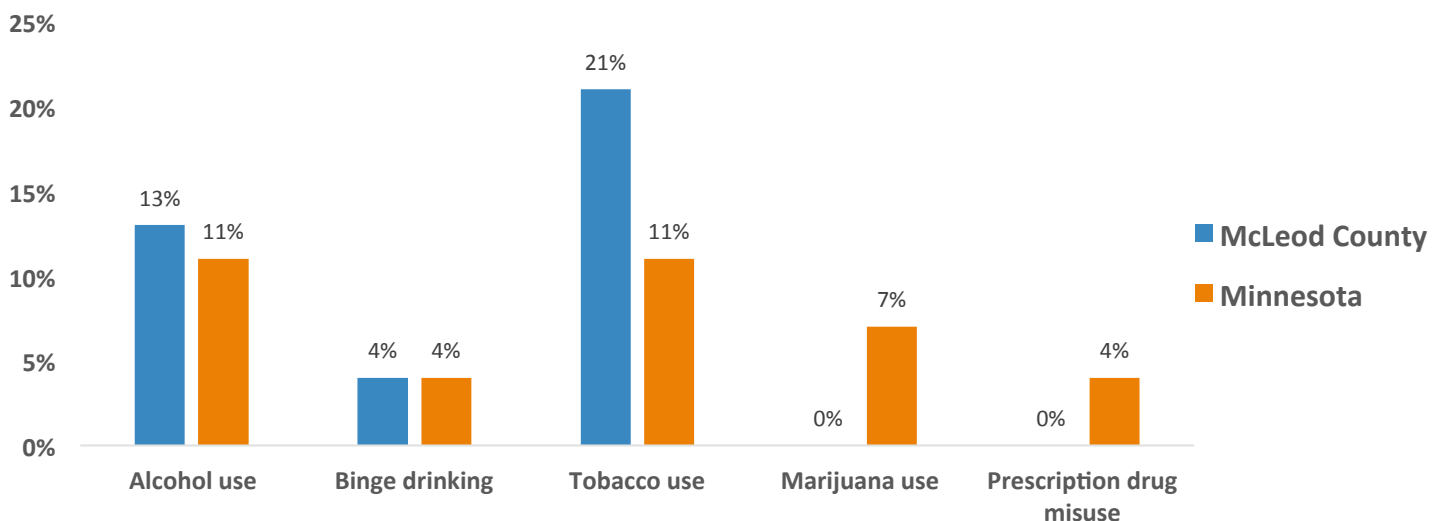
According to the 2015 Minnesota Survey on Adult Substance Use (MNSASU):

- Past-month binge drinking (women having 4+ drinks or men having 5+ drinks in a row on one occasion) was reported by 11% of adults in the Southwest region and 14% of Minnesota adults.
- Past-month cigarette smoking was reported by 16% of Southwest adults and 16% of Minnesota adults.
- Past-month marijuana use was reported by 2% of adults in the Southwest region compared to 5% of adults statewide.

### Youth Substance Use

Data on youth substance use are from the Minnesota Student Survey (MSS). Data are limited when a county doesn't have more than one participating district per grade. ## Alcohol

Past 30-day alcohol use was reported by 13% of 9<sup>th</sup> graders, and 17% of 11<sup>th</sup> graders in McLeod County in 2016. Use among 9<sup>th</sup> graders dropped in McLeod County from 42% in 1998 to 13% in 2016. Past 30-day binge drinking (defined as having five or more drinks in a row on one occasion) was reported by 4% of 9<sup>th</sup> graders, and 10% of 11<sup>th</sup> graders in 2016.

## Tobacco/Nicotine

Of McLeod County 9<sup>th</sup> and 11<sup>th</sup> graders, 21% and 21% reported any past 30-day tobacco use, respectively: 4% and 14% reported smoking cigarettes; 0% and 7% reported smoking cigars or cigarillos; and 8% and 3% reported chewing tobacco use, respectively. In addition, 17% and 21% of 9<sup>th</sup> and 11<sup>th</sup> graders reported e-cigarette use, respectively, and 0% and 3% reported hookah use; questions about these two methods of nicotine use were added to the survey in 2016. Cigarette smoking among 9<sup>th</sup> graders dropped in McLeod County from 21% in 1998 to 4% in 2016.

## Other Drugs

Past 30-day marijuana use was reported by 0% of 9<sup>th</sup> graders, and 7% of 11<sup>th</sup> graders in McLeod County in 2016. Use among 9<sup>th</sup> graders dropped in McLeod County from 8% in 2004 to 0% in 2016.

Past 30-day prescription drug misuse was not reported by any 9<sup>th</sup> or 11<sup>th</sup> graders in McLeod County in 2016. However, 4.2% of 9<sup>th</sup> graders reported past-year pain reliever misuse. No students reported misuse of stimulants, ADD or ADHD medication, or tranquilizers.

## Consequences

### Alcohol

- The DWI arrest rate for McLeod County residents was 44.3 per 10,000 population in 2015, with an average of 53.2 from 2006 to 2015. The state's average was 57.0 (Minnesota Office of Traffic Safety, DPS)
- In 2015, 5.9% of motor vehicle crashes in McLeod County were alcohol-related, compared to 4.7% throughout the state (*Crash Facts*, DPS)

### Tobacco

- The lung, bronchus and trachea cancer death rate for McLeod County has averaged 4.6 per 10,000 population from 2006 to 2015. That's just slightly higher than the state average of 4.5 (Minnesota Center for Health Statistics, MDH)

### Drugs

- From 2000 to 2015, there were 12 opioid deaths (non-exclusive) in McLeod County, of 2,273 total in Minnesota. Over that same 15-year period, there was 1 heroin death in McLeod County; there were 453 in the state as a whole (Minnesota Center for Health Statistics, MDH)
- In 2015, there were 44 arrests for marijuana in Cass County, no arrests for opium or cocaine, 1 arrest for synthetic drugs, and 32 arrests for other drugs, including methamphetamine (*Minnesota Crime Information*, DPS)
