Substance Abuse Prevention

This fact sheet provides county level data on substance use and related factors to help guide decisions about prevention efforts. These data can be used to justify need for prevention funding, monitor substance-related trends, and plan programs and initiatives by establishing community level prevention priorities.


According to 2016 estimates from the U.S. Census Bureau, Yellow Medicine County has 9,935 residents; 23% are under the age of 18.

Key Findings

- Compared to state averages, smaller percentages of Yellow Medicine County students reported past 30-day alcohol use, tobacco use, marijuana use, and misuse of prescription drugs (see Fig. 1).
- Cigarette smoking among 9th graders has declined from 30% in 2001 to 2% in 2016; however, 4% of 9th graders also reported using e-cigarettes in 2016.
- Among Yellow Medicine County 8th, 9th, and 11th graders, those with better teacher-student relationships are nearly 2 times less likely to report past-month prescription drug misuse.
- In 2015, Yellow Medicine County's alcohol-related motor vehicle crash rate and arrest rate for driving while intoxicated (DWI) were higher than the state rates.
- From 2000 to 2015, Yellow Medicine County recorded 4 opioid and 0 heroin overdose deaths.

**Tobacco includes any past month use of cigarettes, cigars, chewing tobacco, electronic cigarettes and/or hookah.

Adult Substance Use

According to the 2015 Minnesota Survey on Adult Substance Use (MNSASU):

- Past-month binge drinking (women having 4+ drinks or men having 5+ drinks in a row on one occasion) was reported by 11% of adults in the Southwest region and 14% of Minnesota adults.
- Past-month cigarette smoking was reported by 16% of Southwest adults and 16% of Minnesota adults.
- Past-month marijuana use was reported by 2% of adults in the Southwest region compared to 5% of adults statewide.

Youth Substance Use

Data on youth substance use are from the Minnesota Student Survey (MSS); Yellow Medicine County students make up 0.2% of the overall statewide sample.

Past year alcohol and/or drug use was reported by 7.5% of Yellow Medicine 5th graders. Questions about past 30-day substance use (covered in the following section) are not asked of 5th grade students.

Alcohol

Past 30-day alcohol use was reported by 3% of 8th graders, 13% of 9th graders, and 18% of 11th graders in Yellow Medicine County in 2016. Use among 9th graders dropped in Yellow Medicine County from 46% in 2001 to 13% in 2016. Past 30-day binge drinking (defined as having five or more drinks in a row on one occasion) was reported by 3% of 8th graders, 4% of 9th graders, and 12% of 11th graders in 2016.

Tobacco/Nicotine

Of Yellow Medicine County 8th, 9th and 11th graders, 8% reported any past 30-day tobacco use; 5% reported smoking cigarettes, 2% reported smoking cigars or cigarillos, and 1% reported chewing tobacco use. In addition, 5% reported e-cigarette use, and 2% reported hookah use; questions about these two methods of nicotine use were added to the survey in 2016. Cigarette smoking among 9th graders dropped in Yellow Medicine County from 30% in 2001 to 2% in 2016.

Marijuana

Past 30-day marijuana use was reported by 3% of 8th graders, 2% of 9th graders, and 11% of 11th graders in Yellow Medicine County in 2016. Use among 9th graders dropped in Yellow Medicine County from 12% in 2001 to 1% in 2016.

Prescription Drug Misuse

Past 30-day prescription drug misuse was reported by 4% of 8th graders, no 9th graders, and 3% of 11th graders in Yellow Medicine County in 2016. Specifically, in the past year, students in these grades combined reported the misuse of stimulants (0.5%); ADD or ADHD medication (0.9%); pain relievers (2.7%); and tranquilizers (0.5%).

Mental health disorders can increase risk of substance use, and substance use can in turn increase the risk for poor mental health. In addition, numerous risk and protective factors are shared between substance use and mental health outcomes.

Contributing Factors

Low perception of harm, low perception of parental disapproval, and misperception of peer use all contribute to alcohol, tobacco, and drug use in a community. Although data are presented here as a group, percentages vary by grade. For data by grade level, or for more protective factors, visit www.sumn.org.

Perceived Harm

Yellow Medicine County 5th, 8th, 9th, and 11th graders were least likely to believe that people put themselves at great or moderate risk of harm, physically and in other ways, by smoking marijuana once or twice per week: 61%. Perceived great or moderate risk of harm for other substances was as follows: consuming five or more alcoholic drinks once or twice per week: 68%; smoking one or more packs of cigarettes per day: 73%; using prescription drug not prescribed for you: 74%.

Perceived Disapproval

Among Yellow Medicine County 5th, 8th, 9th, and 11th graders, 92% said their parents would think it's very wrong or wrong for them to smoke cigarettes. Similarly, students felt their parents would feel it's very wrong or wrong for them to have one or two drinks of alcohol nearly every day (90%), to smoke marijuana (89%) or to use prescription drugs not prescribed for them (92%). Yellow Medicine County students also believe their friends would disapprove of substance use: most students believe their friends would think it was wrong for them to engage in cigarette use (84%); alcohol use (80%); marijuana use (81%); or prescription drug misuse (87%).

School Factors

Yellow Medicine County 8th, 9th, and 11th graders with better student-teacher relationships are nearly 2 times less likely to report past-month prescription drug misuse, and those with greater educational engagement were over 3 times less likely. Similar associations are seen with alcohol, tobacco, and marijuana.

Misperception of Peer Use

Yellow Medicine County 8th, 9th, and 11th graders who think most students at their school drink monthly or more often are over 10 times more likely to report that they themselves drink alcohol monthly or more often.

Consequences

Alcohol

- The DWI arrest rate for Yellow Medicine County residents has fluctuated between 2006 and 2015, averaging 65.2 per 10,000 population, with 53.4 in 2015. The state averaged 57.0 per 10,000 population over the same time period, with 44.7 in 2015 (Minnesota Office of Traffic Safety, DPS)
- In 2015, 10.3% of motor vehicle crashes in Yellow Medicine County were alcohol-related. In comparison, 4.9% throughout the state were alcohol-related (*Crash Facts*, DPS)

Tobacco

- The lung, bronchus and trachea cancer death rate for Yellow Medicine County has fluctuated over time, peaking in 2006 at 13.3 per 10,000 population. By 2015, it was 6.2, averaging 7.3 per 10,000. That's higher than the state average of 4.5 per 10,000 (Minnesota Center for Health Statistics, MDH)

Drugs

- From 2000 to 2015, there were 3 opioid deaths (non-exclusive) in Yellow Medicine County, of 2,273 total in Minnesota. Over that same 15-year period, there were no heroin deaths in Yellow Medicine County; there were 453 in the state as a whole (Minnesota Center for Health Statistics, MDH)
- In 2015, there were 3 arrests for marijuana in Yellow Medicine County, no arrests for opium or cocaine, 1 arrest for synthetic drugs, and 23 arrests for other drugs, including methamphetamine (*Minnesota Crime Information*, DPS)




Figure 3. Admissions to Treatment for Opioids as the Primary Substance of Abuse among Yellow Medicine County Residents Admitted (Drug and Alcohol Abuse Normative Evaluation System)
